### FUNCHAL EUROPEAN CAPITAL OF CULTURE

Open Call for Artistic and Cultural Projects

### **PROLOGUE**

Founded in 1985, the European Capital of Culture programme has been, during decades since its establishment, an important driving force for the economic, social and human development of its covered territories, becoming the main programme of territorial development through investment in the cultural and creative sector and its main activities and actors.

In this context, the municipality of Funchal, assuming the city as a place of convergence and centralism located in the European outermost regions, prepares its application to the title of European Capital of Culture for the year of 2027 based in a logic of diversity and comprehensiveness of the European outermost region. Under the slogan "Beyond the Map, a Common Ground" and outlining a strategic use of its peripheral condition, the team coordinating the application for ECOC2027, defined three fundamental axes for Funchal: multiculturalism in the European outermost regions, city of warm gatherings, and cultural decentralization - on which are settled the criteria to at throughout the conceptual line of the application and serves as a premise for integrating in the main cultural programme the several projects and contributions from Madeira's cultural and creative sector in dialogue with the national and European sphere.

# 1<sup>ST</sup> ARTICLE PURPOSE

This submitting guidelines document is intended to define the selection criteria within the Open Call for projects to be included in the artistic and cultural programme in the context of Funchal City application for the title of European Capital of Culture in the year of 2027.

# 2<sup>ND</sup> ARTICLE DISSEMINATION

Initially, this open call for projects is disseminated among the various actors within Madeira's Cultural and Creative sector through the webinar cycle FUNCHAL ECOC2027 - CALL FOR PROJECTS, secondly at a national level, making use of both traditional and online social media and internationally, in a third phase, by establishing partnerships, coproductions and/or the dissemination of artworks.

# **3<sup>RD</sup> ARTICLE**SUBMITTED PROJECTS

Are admitted for submission to this Open call artistic and/or cultural projects within the scope of: all artistic areas - music, dance, theatre, literature, performance, visual arts, digital arts and crossed disciplines; proposals within the scope of the study and research of the local tangible and intangible cultural heritage, as well as local and/or local and/or European history and heritage. Projects within the scope of natural heritage are also admitted. Bearing in mind the three axes for Funchal's application to ECOC2027 - multiculturalism, city of warm gatherings, and cultural decentralization - projects submitted in this call must evidence minimum criteria, as mentioned below, in order to obtain at least 60 points, as stated in the 7th Article of these guidelines:

These guidelines aim to define the selection criteria for project proposals to be included in the artistic and cultural programming of Funchal City application to the title of European Capital of Culture in 2027:

### as to its nature:

- > artistic projects, all areas admitted;
- > cultural, based on the local cultural heritage (tangible and/or intangible)
- > cultural, based on the European cultural heritage (tangible and/or intangible)

### as to its implementation:

- > open to participants from diverse social groups and minorities
- ➤ ability to tour on the island and/or national or European territories
- > partnerships with European entities and/or artists
- > artistic / cultural relevance
- ➤ aptitude and experience of the management, artistic and production teams
- > ability to innovate
- > ability to attract co-financing / project sustainability.

# **4<sup>TH</sup> ARTICLE**SUBMISSIONS

All proposals submitted to this open call must use the specific Application Form (<a href="https://funchal2027.cm-funchal.pt/en/open-call-for-artistic-and-cultural-projects/">https://funchal2027.cm-funchal.pt/en/open-call-for-artistic-and-cultural-projects/</a>), which must contain the following key elements:

- > concept presentation and main goals;
- > activities description;
- > artistic and production teams description;
- > budget and cost justification;
- > brief history of the applicant.

All applications must be sent by e-mail, not being admitted by other means. In addition to the Application Form, proposals may attach other elements (audio, video or images) that are considered relevant or mandatory to a comprehensive understanding of the idea / project. Each entity (formal or informal) or individual artist may submit more than one project as long as they do not overlap in space or time or as long as there is a team capable of implementing the listed activities.

# DEADLINES, SUBMISSIONS ADDRESS AND IMPLEMENTATION PERIOD

Deadline for this Open Call is **May, 31st 2021**. Applications must be sent using the e-mail: <a href="mailto:projetos@funchal2027.net">projetos@funchal2027.net</a>. All applications will go through evaluation until August, 31st 2021, after which a final decision will be issued.

All applicants and proposals must schedule all activities starting from **January 1st 2022**.

### 6<sup>™</sup> ARTICLE JURY

To guarantee the suitability and transparency of the selection process, all applications will be evaluated by a multidisciplinary jury representing several creative and artistic areas, as well including all fields related to artistic and cultural projects management and its production and communication. The panel will be announced in all Funchal2027 digital platforms as well as in traditional media during the open call period.

# 7<sup>TH</sup> ARTICLE DECISION

All proposals will be evaluated bearing the premises aligned with the fundamental axes of Funchal2027's application to ECOC and listed in the 3rd Article of these guidelines. A punctuation system was assigned to the criteria, as shows the table below. To be selected applications must

reach a minimum of 60 points. Results will be published in Funchal2027 website (<u>www.funchal2027.net</u>).

The evaluation team reserves the right not to grant all the funds requested for a project, being valued proposals showing ability to attract co-funding of their activities.

After the publication of the Panels' decision, a period of 10 days will elapse during which entities that do not agree with the evaluation may request a prior hearing.

# 8<sup>TH</sup> ARTICLE APPLICATION TERMS

Both profit and non-profit collective entities within the regional, national or European cultural and creative sector as well as individual artists with a minimum of two years of proven artistic activity are welcomed to apply to this Open Call. Artistic institutions or other educational entities from the social sector can also apply to this call.

### IMAGE USE AUTHORISATION

By submitting an application to this Open Call, applicants declare to grant the rights to use their image and/or images of their organization and/or its activities in Funchal2027 online platform, including social media (Facebook, Instagram, Twitter, YouTube...), as well as of all partners operating in the same process together with the Municipality of Funchal.
